#### 7) **NEW BUSINESS:**

- a) Review feedback from public forum, comments, and emails
  - Received more detail on fees, cannot rely on website or email to get information out, discussed resurfacing issues at Fairway and Oxford, Optimal amount exceeded what some can pay, one comment that addition staff is not needed and private property should not pay for public airport.



- No comments about having ability to increase fee up to 20%, by Board vote.
- Discussed marketing the airport and suggested that FOCA should get involved.
- Suggestion to track volunteer hours and post on website along with list of volunteer names.
- Some discussion if could do this as a Special Assessment. Requires legal input.
- Mission / Vision Statement should be more prominent on Airport Website.
- Still would like addition feedback/comments. Committee member to continue to talk to their neighbors.
- b) Decide on changes to proposal for the board based on feedback
  - Maintain the increase of \$50 per month per parcel for airport
- c) Decide on next steps
  - i) Communications of proposal to be presented to the board 6/1
  - At May 21 meeting, formulate recommendation to Board
  - At May 28 meeting finalize recommendation
  - Include in Flyer, what residence get for \$75 Airport Fee and \$25 street fee
